CALL FOR PROPOSALS BY TEMPORARY STAFFING FIRMS FOR THE ADJUDICATION OF TEMPORARY STAFFING SERVICE AT THE CONSULATE GENERAL

The Consulate General of Italy issues a call for proposals by temporary staffing firms to provide temporary staffing service at the Consulate General of Italy in Los Angeles The contract will start on January 1, 2024 and will terminate on December 31, 2024

Recipients

This call for proposals is aimed to temporary staffing firms that meet the requirements described below, and that have the expertise, and the technical and management resources to enter such agreement.

Purpose

This call for proposals is aimed to start a constructive dialogue with all interested temporary staffing firms. At this stage, statements of interest submitted with the requested data will not be considered as binding for the Consulate General Administration. Temporary staffing firms submitting statements of interests will not gain preferred placement position in the decision making process of the Consulate General Administration.

Requirements

As a guarantee of sound business practices in the field of temporary staffing service, in the statement of interest companies must include the following documentation:

- Authorization issued by the competent U.S. local authorities to operate;
- Professional capabilities and sound business practice in the temporary staffing service field in the United States;
- Financial statements and business plan.

How to Submit a Statement of Interest
